#### I LOOK FORWARD EVERY YEAR TO WRITING THIS MESSAGE BECAUSE IT GIVES ME AN OPPORTUNITY TO REFLECT ON THE INCREDIBLE WORK DONE BY THE ARIZONA JUSTICE PROJECT OVER THE PREVIOUS

**12 MONTHS.** This year is no different. AS 2024 COMES TO A CLOSE, I AM PROUD TO NOTE THAT THE COLLECTIVE WORK OF THE ARIZONA JUSTICE PROJECT OVER THE LAST 26 YEARS HAS HELPED 51 CLIENTS REGAIN THEIR FREEDOM AND RETURN HOME! This year alone, three clients (Greg, Atdom, and Iris) walked free! The work behind each one of our cases is made possible thanks to our supporters.

Since the organization's inception in 1998, the AJP's founder, the late Larry Hammond, had a knack for building teams and bringing together the nation's top forensic experts (DNA, fire science, ballistics, etc.), investigators, and legal practitioners to work, for free, on AJP cases. Today, we are still at it. Each case that we pursue is carefully selected and an investment in correcting a serious injustice. The organization's ability to tackle difficult feats has been, and still is today, on the shoulders of incredible teams of dedicated people.

There is no shortage of individuals who need our help. Each year, hundreds of individuals in prison reach out to the AJP with claims of innocence, manifest injustice, or marijuana record expungement. AJP staff and interns tirelessly vet each case and, in the end, only a fraction of the cases move forward to investigation and legal representation. It takes years of work between the time we accept a case to when a client walks free. The work doesn't stop there. Our dedicated Re-Entry team assists clients in making a successful transition back into the community. This year we advanced efforts to cut down on wrongful convictions before they occur with policy reforms, such as improving eye-witness identification procedures. We pursued sentencing fairness through strategic litigation in the courts and worked with law makers on a bill to allow a limited number of people a chance at parole. In 2025, we will launch an effort to pass a law allowing those who have been wrongly convicted in Arizona to apply for recompense for the time and freedom lost.

At the end of the day, the greatest joy is witnessing our freed and exonerated clients rebuild their lives and emerge as leaders in the community. These men and women are using their voices to support one another and to improve the system for those still incarcerated.

#### FREDDY RAMON

#### FREDDY RAMON RECEIVED AN ABSOLUTE DISCHARGE THIS YEAR!

Freddy was only 15 years old when he and two other teenagers were arrested and charged with felony murder. A shooting at a convenience store resulted in one person's death. Though Freddy was in the vehicle when the shooting inside the store occurred, he was charged and convicted for the crime.

After serving 28 years in prison, Freddy was released on parole in December 2020 and entered into a transitional housing program where he thrived. From there, Freddy obtained full-time employment and met his now-fiancée!

In September of this year, the Board of Executive Clemency recognized Freddy's contributions to the community, excellent employment history, relations with family and friends, support system, disciplinary-free parole record, and granted him an absolute discharge. Congratulations to Freddy!

#### **GREGORY SCHMIDT**

#### GREG REGAINED HIS FREEDOM ON MAY 10, 2024, AFTER 26 YEARS OF

**INCARCERATION.** Greg was convicted for a 1998 offense and sentenced to 25 years in prison. For over 20 years, Greg maintained a spotless disciplinary record, engaged in programming, education, community service, and employment to prepare himself for coming home one day.

In 2021, Greg contacted the AJP for help after a notification was circulated in the prison about release eligibility. Greg was told that he was not eligible for release or for parole consideration, which meant Greg would likely spend the rest of his life in prison.

After a review of his case and sentencing record, AJP determined that any further incarceration beyond the 25-year mark would be unjust punishment. In partnership with pro bono assistance from the law firm Coppersmith Brockelman, AJP filed a civil lawsuit seeking Greg's release from prison.

The lawsuit was quickly settled, and Greg was released from the Yuma prison facility into the arms of his sister and the AJP team! Greg was welcomed home by his supportive family.



#### **IRIS VILLA**

#### IRIS WAS RELEASED ON OCTOBER 24, 2024, AFTER SERVING OVER SIX YEARS IN PRISON Tris was

initially sentenced to 14 years in prison. AJP attorney, Martin Hutchins, represented Iris as part of our Marijuana Expungement Program.

During a review of Iris's case, it was discovered that a prior drug conviction was used incorrectly to enhance her sentence. In addition, Iris was one of several co-defendants in the case but received the harshest sentence of 14 years, while all other co-defendants were sentenced to 3-4 years on probation, despite being equally involved in the offense. Based on those two factors, the judge re-sentenced Iris to time-served!

During her incarceration, Iris focused on self-improvement, engaged in programming, and acquired skills that will be valuable as she reintegrates into the community. Iris's family has provided unwavering support and continues to stand by her upon release.

## **FREEDOM ACHIEVED IN 2024**



#### ATDOM PATSALIS

#### ATDOM REGAINED HIS FREEDOM IN SEPTEMBER 2024 AFTER SERVING ALMOST 11 YEARS IN PRISON. At age

20, Atdom was prosecuted on 25 counts of non-violent burglary-related crimes. When police interviewed Atdom on the burglaries, he took responsibility and told police where to find the stolen items so they could be returned to their owners. However, when it came time for punishment, the Mohave County Superior Court judge sentenced Atdom to 292 years in prison. This was the most excessive punishment case we have ever seen at the Project.

In 2018, Atdom wrote to the AJP for help. AJP took on Atdom's case and over the next five years represented Atdom through the federal system of review arguing that the 292-year sentence violated the 8th Amendment's prohibition against cruel and unusual punishment. Unfortunately, the courts denied relief. In 2023, we threw the "Hail Mary" seeking a commutation (shortening) of sentence through Arizona's Executive Clemency process. The AJP presented statewide sentencing data showing that the average sentence for someone in Atdom's position was 5-7 years, and not 292 years. Members of the Arizona Board of Clemency recommended a commutation of sentence from 292 years to "10 years to life." On July 24, 2024, the Governor granted commutation.

While incarcerated, Atdom worked hard not to lose hope. Atdom is now 31 years old and sober. He spent his days in prison reading books on psychology and philosophy, working in the recreation room, practicing cross-fit and yoga, making cheesecake, writing a book, and creating music that he hopes to perform in the free world.

# RECLAIM YOUR FUTURE

EXPUNGING PAST MARIJUANA RELATED RECORDS

THE RECLAIM YOUR FUTURE (RYF) CAMPAIGN MARKED ITS THIRD YEAR ON JUNE 30, 2024. LAUNCHED ON JULY 1, 2021, THE CAMPAIGN WILL CONTINUE THROUGH JUNE 2025, AIMING TO PROVIDE OUTREACH AND LEGAL SERVICES FOR THE EXPUNGEMENT OF MARIJUANA OFFENSES IN ARIZONA.

> The passage of Proposition 207 ("Prop 207") legalized adult recreational use of marijuana and provided a path for individuals with convictions and arrest records to have those matters undone and sealed.

> Prop 207 also required the Department of Health Services to award grant funding to non-profit organizations to engage in expungement-centered work for the community. AJP, along with six other legal and community organizations, work in collaboration under this grant to fulfill the RYF campaign. **RYF educates individuals and entities about the marijuana expungement law and expands access to expungement to as many people as possible.** The RYF Campaign has been incredibly successful throughout its 3 ½ years of operation.

# SINCE ITS INCEPTION, RYF HAS ACCOMPLISHED THE FOLLOWING:

- Held 233 clinics to educate the public about their rights under Prop 207.
- Provided direct representation in 267 cases.
- Launched 2,433 ads across digital and printed platforms and held 303 informational sessions.
- Provided legal assistance leading to the completion of 760 self-representation petitions.



- Tracked 992 successfully granted petitions, which include petitions filed through direct representation and self-represented litigants.
- Successfully litigated the re-sentencing of six individuals which led to three of them being immediately released from prison.
- Worked with The Civil Rights Restoration of Rights Clinic at University of Arizona's Law School leading to approximately 1,000 expungements being granted.
- Partnered with Ben & Jerry's to launch an email campaign encouraging prosecutors to file expungement petitions on behalf of impacted people.
- Partnered with Free Our Vote for a mail campaign targeting people with convictions that may have impacted their voting ability.

# AJP RE-ENTRY TEAM

UNDER THE LEADERSHIP OF AJP'S DIRECTOR OF SOCIAL WORK, TANSHA HARRELL, AJP HAS CONTINUED TO ASSIST CLIENTS BOTH BEFORE AND AFTER RELEASE FROM INCARCERATION.

In Arizona, there are very few re-entry services for those released from prison. To address specific re-entry needs, our social work team creates a tailored plan for each client who is preparing to re-enter into the community and provides vital support upon release.

A re-entry plan often includes identifying housing, employment, counseling, and access to basic needs such as healthcare and food assistance. The realities of re-entry are nuanced, and it takes a creative and strategic approach to formulate and implement a successful plan. Thank you to our re-entry team for their dedication to our clients!







# LARRY HAMMOND JUSTICE FELLOW THYME MORTON

IN SEPTEMBER, WE WELCOMED THYME MORTON AS THE SECOND LARRY HAMMOND JUSTICE FELLOW, a position funded by The Lodestar Foundation.



Thyme earned her Bachelor of Arts in International Relations and Spanish from Wellesley College before graduating with her J.D. from Boston College Law School. During her time at Boston College, she gained valuable experience as a student attorney in the Parole and Compassionate Release Clinic, navigating the intricate social, legal, and political issues surrounding parole and compassionate release.

# STRATEGIC LITIGATION AND POLICY INITIATIVES TO CREATE A FAIRER SYSTEM

THROUGHOUT THE YEAR, WE CONTINUED TO EDUCATE THE COURTS VIA FRIEND OF THE COURT BRIEFS AND PROPOSE LEGISLATION ON ISSUES WE BELIEVE ARE IMPORTANT TO CREATE A FAIRER SYSTEM FOR ALL.





Approximately 30 youth offenders in Arizona are serving a sentence of natural life, which means they are not eligible for any type of early release, including clemency. AJP continues to act as a clearinghouse for lawyers seeking re-sentencing hearings for these individuals.


# JUVENILE LIFE WITHOUT PAROLE

SINCE THE U.S. SUPREME COURT'S DECISION IN MILLER V. ALABAMA IN 2012, THE ARIZONA JUSTICE PROJECT HAS ADVOCATED FOR YOUTH OFFENDERS SENTENCED TO LIFE WITHOUT PAROLE THROUGH LITIGATION, ADVOCACY AT PAROLE HEARINGS, AND SUPPORT FOR POLICY CHANGES.

AJP's Senior Litigation Counsel, Karen Smith, along with the Federal Public Defender's Office, Arizona Attorneys for Criminal Justice, the Arizona Capital Representation Project, and the National Association of Criminal Defense Lawyers filed an amicus brief in a case before the United States Supreme Court. This brief asked the court to review the Arizona Supreme Court's recent decision, which denied youth offenders the opportunity to prove they were improperly sentenced. In our work at the Project, we have witnessed that young people have a remarkable capacity for change and rehabilitation. By denying juveniles the chance for life beyond prison walls, we undermine principles of humanity.

AJP also continues to advocate for youth offenders through representation at parole hearings. AJP, with assistance from volunteer attorney Donna Berlinski, helped Tiffanie, a youth offender sentenced to life with the possibility of release after 25 years, succeed in securing release on parole.





# POLICY REFORM

Our Strategic Litigation Counsel, Hope DeLap, along with our Executive Director, Lindsay Herf, met with Everett Berry, Representative David Marshall Sr., and Jim Norton in Flagstaff to discuss legislation that would address parole fairness within the Arizona criminal justice system.

As part of this Program, AJP has also successfully advocated for parole for several people- three of whom were released this year.

# EYEWITNESS IDENTIFICATION

MISTAKEN EYEWITNESS IDENTIFICATIONS CONTRIBUTED TO APPROXIMATELY 72% OF THE DNA EXONERATIONS THAT HAVE OCCURRED IN THIS COUNTRY.

Decades of research in social and memory sciences inform the criminal justice system on how eyewitness identification evidence is collected, emphasizing procedures used by law enforcement to reduce misidentification and improve accuracy.

Over the past year, Strategic Litigation Counsel, Hope DeLap, worked with the Arizona Attorney General's Office (AZAG) to survey law enforcement agencies on their current eyewitness identification practices.

We found that there is no uniform eyewitness identification procedure in Arizona and each law enforcement agency has slightly different policies and procedures.

The AJP then convened a working group, including members of the Arizona Attorney General's Office, a judicial officer, a retired judge, a policy expert, and an ASU social science professor Dr. Laura Smalarz. The working group ended 2024 with consensus on statewide recommendations for law enforcement to utilize in its collection of eye witness identification evidence in criminal investigations.




